**WHEREAS**, our county is extremely concerned about the impacts to our children of any further delays to in-person education.

**NOW, THEREFORE, BE IT RESOLVED** that the Butte County Board of Supervisors hereby that these facts demonstrate a need for collective and unified action from our county and surrounding communities; and

**BE IT FURTHER RESOLVED** that Butte County approve this Resolution with a commitment to the following principles:

1. That our county is best served by an ability to respond locally to the COVID-19 virus in accordance with our local data and circumstances, as specified, for instance, in the attestation filed with the California Department of Public Health.
2. That our county is geographically diverse and better suited for more localized restrictions than the county-wide restrictions imposed by the *Blueprint*, and the State should enable our COVID-19 response to be tailored to geographically separate areas, such as different zip codes, as circumstances and case levels warrant.

3. That the Board of Supervisors support opening all schools as soon as it is safe to do so and provide in-person instruction to the greatest extent possible without unnecessary delay.

**WHEREAS**, our county has seen increases in drug abuse, delayed medical care, depression among our youth, and the overall increased need for mental health services;

**WHEREAS**, our County is extremely concerned about the impacts to our children of any further delays to in-person education and reestablishment of extra-curricular activities; and

**WHEREAS**, the State's vaccine distribution system has failed to recognize the lack of supplemental vaccination opportunities such as Multi-County Entities and corporate pharmacies in rural jurisdictions, thereby severely limiting the number of vaccines available to our constituents.

**NOW THEREFORE BE IT RESOLVED**; the Colusa County Board of Supervisors, recognize that these circumstances demonstrate a need for collective and unified action from our County and surrounding Communities with a commitment to the following principles:

1. That our county is best served by an ability to respond locally to the COVID-19 virus in accordance with our local data and circumstances.
2. That our county is geographically diverse and ill-suited for the county-wide restrictions imposed by the *Blueprint*, and the State should enable our COVID-19 response to be tailored to geographically separate areas, such as different zip codes, as circumstances and case levels warrant.

3. That school districts in our jurisdiction are urged to safely open all schools as soon as possible and provide in-person instruction to the greatest extent possible without further delay.
4. That all sports and other extra-curricular activities, such as FFA, Parliamentary Procedure, Music and Debate, are allowed to fully begin in-person participation and competition.

**WHEREAS**, El Dorado County has developed outstanding, collaborative relationships between public health, local business chambers, local hospitals, the City of Placerville, the City of South Lake Tahoe and education leaders, providing a strong framework to ensure any decisions made relative to managing the spread of COVID-19 while also balancing the impacts on local businesses and the overall health and well-being of our residents; and

**RE: Local response to COVID-19 pandemic**

Dear Governor Newsom,

Modoc County was placed in a difficult position at the onset of the COVID-19 pandemic. With zero cases in our county for many months, there were many who felt we should not participate in the recommended actions from the State of California to address COVID-19. As time passed and an increase in cases began to occur, Modoc County found that the one-size-fits-all blueprint did not address the unique needs of our rural communities. The increased communication from the state health officials with our County Health Officer and Public Health Director created a coordination effort that was implemented at a local level and met the needs of our communities. The team of local healthcare professionals has acted in alignment with their mission "to safeguard and promote the health and welfare of the people of Modoc County." Science and the advice and counsel of the State Health Officer, County Public Health Officer, and Public Health Director has guided our local health response team during the public health crisis.

The response team was further supported by the Modoc County Board of Supervisors who believe that the American concept of "government of the people, by the people and for the people" is best served when government affairs are conducted as close to the people as possible, at the county level. In Modoc County, we have seen the following positive outcomes of a collaborative approach between state and local health officials:

- Due to a locally driven response, all Modoc County schools are open and currently operating with safe guidelines and procedures to protect our youth and faculty.
- Successful vaccination rates throughout the remote areas of our rural communities
- Harvest worker vaccination program and communication on safe protocols
- Low case rate of COVID-19 throughout Modoc County

Rather than pass the recommended *Healthy Communities Resolution*, the Modoc County Board of Supervisors would like to encourage the State of California to engage stakeholders (counties and their citizens), early in the problem-solving and decision-making processes, prior to issuing Executive Orders, restrictions, plans, and guidance that affect rural communities who differ from the rest of the state. As an example of the success of local input, we in Modoc County, have successfully engaged in Coordination with our Federal partners as required under Federal laws 91-190 and 94-588. The purpose of this Coordination is conflict resolution by 1) using early meaningful involvement by local government in the federal planning process and by 2) striving to achieve consistency in the outcome. This has been a win-win for the agencies, the residents and the environment. We see no reason why the same approach could not be applied to the COVID-19 public health crisis.

Therefore, the Modoc County Board of Supervisors welcome any and all collaboration with your office and state leaders to improve the service delivery at the local level in response to the COVID-19 pandemic. Through clear communication and collaboration, rural counties will be able to remain compliant with state and federal requirements while meeting the unique needs of our communities. We support all California counties efforts to combat the COVID-19 pandemic and realize that each county has their own challenges that should be considered individually and carefully by state leadership.
